Brief summary of goods/services to be provided	<p>Circularity is one of the main mechanisms we have to activate on a large scale to face climate emergency adequately and effectively. This requires many people around the world has to think and act in a circularity paradigm. To make massive learning possible EIT Climate-KIC's Education team have created the Circular Learning Site (Circularity Platform)– blended learning programme designed to deliver circular economy actions in a range of settings including business, NGOs and municipalities. The resources of this programme are focussed around the Circularity Thinking methodologies created by Professor Dr Fenna Blomsma (and colleagues) who is currently professor for Circular Economy and Systems Innovation at Hamburg University. The tools are targeted at creating impact by operating in a circular way and include methods to identify waste creation, identify how to turn waste into value and create a circular strategy for implementation. The tools and approach have been used in Climate-KIC deep demonstrators (e.g., Slovenia) and also adopted by external partnerships such as the Irish National Platform for Circular Manufacturing.</p> <p>EIT Climate-KIC are requesting quotation for 3-4 senior experts in circularity for up to 12 days each. Experts should have proven experience in creation learning content, delivery blended learning courses on circularity in different contexts and sectors (ideally different countries), delivery Train the Trainers courses on circularity and high-profile expertise in building-in circularity paradigm into system transformation processes.
