## NetZeroCities (NZC) Pilot Cities Programme

### About NetZeroCities

NetZeroCities (NZC) is a four-year project that is funded by the Horizon 2020 Research and Innovation Programme, in support of [European Union's Green Deal](#). It is designed to help cities overcome the current structural, institutional, and cultural barriers they face and enable them to **achieve climate neutrality by 2030**. The NZC project offers advanced capabilities related to systemic change; citizen engagement and participation; participatory and innovative governance; capital and financial structuring; and social innovation, to ensure cities have access to expertise needed to address their challenges in becoming climate neutral.

NZC will support the EU's Mission of "[100 Climate-Neutral and Smart Cities by 2030](#)", newly launched as part of the Horizon Europe programme. The project will work as a service-oriented platform supported by world-class practitioners. It will help European cities by providing them with the support and solutions they need to achieve their net-zero goal in a socially inclusive way.

New and existing tools, resources, and expertise will be developed and promoted into a one-stop platform accessible to all cities through an online portal. Dedicated services will be designed to **support cities that are part of the EU's Mission "100 Climate-Neutral and Smart Cities by 2030"**. In addition, NetZeroCities will support a series of **Pilots** to help drive rapid learning about how to achieve climate neutrality at city scale, and run a **twinning programme (City Learning Programme)** to enable peer-learning.

### NZC Pilot Cities Programme

The NZC Pilot Cities programme will identify and support European cities to test and implement innovative approaches to rapid decarbonisation over a two-year pilot programme, working across thematic areas and functional silos in support of systemic transformation. The selection of Pilot Cities will seek to address all urban systems, including mobility, energy systems and the built environment, material and resource flows, natural areas, cultural/social/financial/institutional systems, and accessible public spaces. Any one pilot might target all or a combination of these urban systems, depending on their context and the scale of the proposed pilot.

The Pilot Cities are expected to test and implement innovative solutions, or groups of solutions, at city or district level over the duration of the pilot project, surfacing explicit lessons learnt from the innovative trajectories, with knowledge, capacity and capabilities developed at a city level. A clear set of innovative solutions ready to be implemented, scaled and/or replicated should be identified by the end of the pilot project. This could include new business models, policy initiatives, governance innovation, funding or financing models, and replication or scaling strategies.

Selected pilot cities will receive funding and hands-on support from City Advisors and NZC Consortium partners



to refine their pilots before starting implementation. As cities and/or local communities participating in pilot work to leverage additional resources, the Mission Platform will assist them in building funding and financing for full implementation and subsequent replication and scaling efforts.

Finally, numerous activities will be organised to advance learning among Pilot Cities as a key component for building capabilities, replicating successful innovations, and deepening relationships. A twinning programme (City Learning Programme) will link each lead city with two or three twin cities from across EU member states. The twinning effort aims at building inclusive participation in effective climate action, nurturing just transitions, and building social cohesion.

The coordination of and across selected pilots is a necessity both at the city scale and the EU scale in order to build a diversity of proof-points showing pathways for further and far-reaching transformation in European cities and across the European Union. The pilot selection process therefore aims to construct a strategic portfolio where each pilot has the potential to test and demonstrate the viability of a pathway to change in a particular context. Together, pilot cities are complementary in painting the picture of what systemic change could look like.

## NZC: Scope of work for Independent Experts

EIT Climate-KIC will assign external experts to support the evaluation of the applications received for the NZC Pilot Cities Programme Call. The portfolio of proposals to be evaluated will pertain to the NZC priorities: the transition of relevant city systems, domains related to their main emissions sources, and to the climate-neutral city transition (stationary energy/built environment, energy generation, mobility and transport, green industry, circular economy, and nature-based solutions). Skills, professional experience, and expertise linked to at least one NZC priority are welcome. An appreciation of systems thinking, and systems change, are core to the objectives of this programme.

Assigned Experts shall get acquainted with the relevant background documents (all [Call-related documents and guidelines](#)) and attend the online briefing training with EIT Climate-KIC before starting to evaluate the Pilot Cities Programme proposals.

They shall qualitatively evaluate the assigned proposals according to the evaluation criteria established in the [Call Guidelines](#) and in line with the instructions for Experts. Experts must appraise each criterion (and each related question) with a score accompanied by a clear qualitative statement, clearly justifying the given score as well as providing evaluation conclusions per criterion. If applicable, suggested recommendations/conditions should be included. All evaluations shall be provided in English.

Where required, Experts shall be available to discuss their evaluation with other Experts in consensus meetings convened by the NZC consortium.

## Assignment for the NetZeroCities Pilot Cities Programme Call

Each proposal received for the NetZeroCities Pilot Cities Programme call will be reviewed by at least two independent expert reviewers, with each reviewer anticipated to review 3-5 reviews and undertake a briefing and system training.

Successful applicants who join this pool of experts will require the following to be considered for assignment to review under the NZC Pilot Cities Programme:

- In-depth knowledge of one or more of our priority areas:
  - consumption of electricity generated for buildings, facilities, & infrastructure (stationary energy; built environment etc.),
  - consumption of non-electricity energy for thermal uses in buildings & facilities,
  - energy generation,
  - mobility and transport,
  - green industry,
  - circular economy,
  - nature-based solutions,
  - multi-sector waste management and disposal,



- industrial process emissions,
- land use (agriculture, forestry, and other land uses);
- Knowledge, experience, expertise in:
  - policy and governance,
  - social innovation,
  - democracy and participation,
  - urban economics,
  - sustainable development,
  - business and finance,
  - climate change mitigation and adaptation,
  - urban planning and/or built environment sector technology (especially digitalisation and/or smart cities),
  - transport and mobility,
  - energy sector,
  - digital solutions;
- Good understanding of systems innovation, systems thinking, and systems change.

Prior to any work assignment, you will be issued guidelines covering a description of the tasks, duration, remuneration rates, and reimbursement methods (“Statement of Work”). The per-review rate for this call is 175 EUR; based on approximately 3.5 hours of services per review (i.e., half a day’s work), including the required training.

Experts appointed to work on this activity will be issued both a Code of Conduct, including a confidentiality section, and a Conflict of Interest for each assignment to be reviewed and signed.

## Background to the Call for Independent Experts

EIT Climate-KIC appoint a pool of independent experts with subject matter expertise to conduct ad hoc reviews and other tasks in support of our activities. Independent experts are appointed to the pool using a selection process. When a review or other task is required, appointed experts are contacted to confirm availability and support review.

## Confidentiality

## Scope of Work

Independent Experts, as peer reviewers, may be invited to perform the following tasks on an ad hoc basis for NZC:

- Evaluate proposals following the assessment process and guidelines. This process requires critical assessment of proposals, completion of a scoring sheet template with detailed justifications, and to provide conditions and recommendations as necessary.
- Attend and participate in meeting to discuss their evaluation with an assessment rapporteur and other reviewers to understand and clarify questions regarding the assessment process and discuss the outcomes of the assessment.
- Participate in stage gate or progress meetings for further assessment, evaluation, or monitoring actions if necessary and depending on the conditions stipulated for each proposal.
- Similar tasks related to the evaluation of proposals and/or projects.

This principal purpose of this call is to source Independent Experts to support the proposal evaluation of the NZC Pilot Cities Programme 2022.

Applicants will register their areas of expertise as part of the application process. We may request further information from Independent Experts on areas of expertise from time to time.

## Who are we looking for

Applicants to NZC's Independent Expert pool are anticipated to be:

- Educated to a post-graduate degree level in a relevant field, or have 8 years of experience within a specific industry
- Experienced in providing reviews or similar independent services for funding institutions
- Experienced with international programmes and organisations
- Fluent in English (required), written and verbal

Further, we are looking for candidates with:

- High-level of expertise, and/or applied experience, in at least one (but preferably multiple) of the thematic and priority areas of work that NZC is engaged in, as outlined in the linked [questionnaire](#).
- Excellent understanding of EU regional policy framework, EU programmes supporting regional transitions, including EU structural funds (infrastructure, cohesion, modernisation funds) Understanding of Horizon Europe framework or other EU funding mechanisms is preferable.
- Good understanding of systems innovation, systems thinking, and systems change.

## Minimum Eligibility Criteria

Independent Experts are required to meet eligibility criteria to ensure the integrity of appointment and the assessment process. This includes ensuring appointments and reviews are free from conflicts of interest.

### Minimum Eligibility Requirements

Candidates are **not** affiliated to or employed by an EIT Climate-KIC grant beneficiary (including, but may not be limited to, an EIT Grant recipient, NetZeroCities grant recipient, parties in consortium with EIT Climate-KIC, or another subgrant recipient)

Candidates are otherwise free from conflicts of interest to participate in the Call for Independent Experts



Candidates are **not** engaged with EIT Climate-KIC in any other form (e.g., in a consultancy contract)

Please note that Independent Experts can only be engaged as reviewers for proposals (not under another concurrent contract with EIT Climate-KIC).

Independent Experts must be free from conflicts of interest regarding any proposal or project they are appointed to review. This will be confirmed at the point of the Assignment Summary.

EIT Climate-KIC must receive a copy of the CV and submitted online form by the Deadline for receipt of submissions. EIT Climate-KIC reserves the right to reject applications that are incomplete or do not meet the minimum eligibility requirements.
